## RECOMMENDATION

Recommendation of the City Manager that City Council approve a side letter agreement between the Torrance Professional and Supervisory Association (TPSA) and Management which adds the position of Accounting Supervisor.

## FUNDING

None required.

## DISCUSSION

In previous years, Management and the various employee groups have produced “side letter” agreements to address issues that come up in between contract negotiations. A side letter is an agreement between an employer and union that typically: (1) modifies, clarifies, or interprets an existing provision in an MOU; or (2) addresses issues of interest to the parties that are not otherwise covered by the MOU.

Such agreements need to be approved by the City Council in an open session. This is particularly important if the side letter agreement pertains to potential PERSable income (i.e. salary adjustment) and premiums. As such, Staff requests the formal approval of City Council memorializing the following:

The subject Side letter agreement between the Torrance Professional and Supervisory Association (TPSA) and Management which adds the position of Accounting Supervisor. The annual fiscal impact will be \$10,413 and was included in the budget as part of the FY 2025-27 Proposed Operating Budget.
