Subject: Community Development – Approve Easement Quitclaim Deed Between City of Torrance and Torrance Unified School District. Expenditure: None.

RECOMMENDATION

Recommendation of the Community Development Director that City Council approve an easement quitclaim deed between City of Torrance (City) and Torrance Unified School District (TUSD), thereby relinquishing the City's water easements within the Hamilton Adult Education Center to the TUSD. The easement transfer will facilitate unrestricted site use for TUSD's future development plans and align with shared goals to enhance school resources and infrastructure.

FUNDING

None required.

DISCUSSION

The Moneta Water Company and Ocean View Development Corporation, Inc. transferred the rights, title, and interest of a water distribution system including water mains, hydrants, valves, meters, fittings, services, and other appurtenances to the City through a recorded quitclaim deed in 1967 (see attachment). This transfer established City water easements, including several within the TUSD-owned property located at 2606 W 182nd Street (APN: 4095-019-900), enabling the City to maintain necessary access and control over its existing water infrastructure. The said property is where Hamilton Adult Education Center is situated.

Recently, the TUSD requested that the City relinquish all City water easements within the Hamilton Adult Education Center lot. The proposed quitclaim of the existing easements to TUSD would eliminate the encumbrance, granting TUSD unrestricted use of the property for future development aligned with school operations and community benefits. The water facilities within the Hamilton Adult Education Center will consequently be maintained by the TUSD.
