Jackson Council Chamber located at 3031 Torrance Boulevard, Torrance, the Torrance City Council will hold a public hearing at which the City Council will hear and consider information concerning the issuance, from time to time, pursuant to a plan of finance, of one or more series of revenue bonds by the California Enterprise Development Authority (the "Issuer") in an aggregate principal amount not to exceed \$37,000,000 (the "Bonds") for the benefit of Benevolence Industries Incorporated, a nonprofit public benefit corporation duly organized and existing under the laws of the State of California (the "State"), d/b/a Benevolence Health Centers, and/or a related entity (the "Borrower").

The Borrower is an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), and will own and operate the Facilities in connection with its mission of providing quality health care and excellent educational programs to the under-served and uninsured in Southern California. The Bonds will be paid entirely from repayments by the Borrower under the Loan Agreements.

Neither the faith and credit nor the taxing power of the City of Torrance (the "City"), the State, or any other political corporation, subdivision or agency of the State is pledged to the payment of the principal of, premium, if any, or interest on, the Bonds, nor shall the City, the State or any other political corporation, subdivision or agency of the State be liable or obligated to pay the principal of, premium, if any, or interest on, the Bonds. The Public Hearing is intended to comply with the public approval requirements of Section 147(f) of the Internal Revenue Code.

MEMBERS OF THE PUBLIC ARE INVITED TO ATTEND THE HEARING to provide public testimony and comment, contest, oppose, or support the use of the tax-exempt bonds for a non-profit borrower that is providing a public benefit.
