RECOMMENDATION

Recommendation of the City Manager that City Council reappoint Kimberley Miller as representative to the South Bay Workforce Investment Board for the City of Torrance.

FUNDING

DISCUSSION

Since July 1, 2015, the South Bay Workforce Investment Board (SBWIB) has managed the federal funds distributed by the state that provide workforce development employment and training services for the community in the City of Torrance.

The current Board has 50 members, comprised of representatives from the 10 cities that encompass the South Bay workforce investment area, as well as neutral seats representing partnering organizations. Kimberley Miller, Vice President of Human Resources for Bachem Americas, Inc., has agreed to continue representing the business community of Torrance on the Workforce Investment Board, and is seeking Council's support for her reappointment:

With the Council's concurrence to approve this reappointment, Ms. Miller will hold a business private sector seat on the South Bay Workforce Investment Board for the City of Torrance for the term July 1, 2025 until June 30, 2029.

Dear Mr. Chaparyan:

Currently, there is one Torrance business private sector seat on the South Bay Workforce Investment Board (SBWIB), that needs to be filled. The new term of office for this seat will take effect July 1, 2025, through June 30, 2029.

Pursuant to the legislative mandates outlined in the Workforce Innovation and Opportunity Act (WIOA) of 2014, Public Law 113-128, for the creation and composition of the Workforce Investment Boards Private Sector Members of the South Bay Workforce Investment Board must be nominated by local business organizations or business trade associations. Nominees are appointed by the Participating Cities' Mayor and City Council and ratified by the South Bay Workforce Investment Area Chief Locally Elected Official.

On March 18, 2025, the Torrance Area Chamber of Commerce re-nominated Ms. Kimberley Miller, Vice President of Human Resources for Bachem Americas, Inc., to serve a full four-year term on the SBWIB as a Torrance business private sector representative. Ms. Miller was appointed last year under an existing term of office, with a term end date of June 30, 2025. We are requesting that the Mayor and City Council please initiate the process to re-appoint Ms. Kimberley Miller to the SBWIB at the City of Torrance's next regularly scheduled City Council meeting or at your earliest convenience.
