Subject: Police – Approve Third Amendment to Contract Services Agreement for Additional TASER Units and Enterprise Fusus Access. Expenditure: \$233,584.65 (General Fund).

RECOMMENDATION

Recommendation of the Chief of Police that City Council approve a third amendment to the contract services agreement with Axon Enterprise, Inc. of Scottsdale, AZ (C2022-184) in the amount of \$233,584.65, for a new not-to-exceed amount of \$10,882,724.86 over a 10-year period beginning May 7, 2024 and ending May 6, 2034 to provide additional TASER units and Enterprise Fusus access.

FUNDING

Funding is available in anticipated salary savings for FY 24-25. Funding for the subsequent years will be included in the citywide budget approval process.

DISCUSSION

On December 6, 2022, your Honorable Body approved a contract services agreement with Axon Enterprise, Inc. (Axon) of Scottsdale, AZ, for the purchase of body-worn and in-car cameras and accessories. On September 12, 2023, your Honorable Body approved the first amendment to this agreement, which established a revised payment plan to maximize the 2023 Federal Discretionary funding award of \$1,615,000. This amendment also corrected an error in the original contract by replacing an incorrectly attached quote with the revised payment plan.

On May 7, 2024, your Honorable Body approved a second amendment to the agreement, granting the Police Department access to Axon's Officer Safety Plan (OSP) Premium package. This ten-year package includes a comprehensive set of cloud-based solutions, facilitating near-complete integration with the department's body-worn and in-car cameras.

Currently, the Torrance Police Department (TPD) contracts with Axon to provide Body-Worn Cameras (BWC), TASER devices, and public safety software. During the implementation phase of the OSP Premium package, it has become evident that there is a shortage in the allocation of TASER devices. Originally, the department requested 130 TASER units under the agreement, but additional units are needed to ensure full coverage for all sworn personnel and field Police Services Officers. Therefore, staff recommends increasing the TASER allocation by 70 units, for a total increase of \$233,584.65.

Fusus, a widely recognized open ecosystem platform, integrates with multiple data sources, including public and community video feeds, and utilizes artificial intelligence for enhanced situational awareness. The initial agreement approved by your Honorable Body included the basic FUSUS licensing. However, with the planned expansion of video feed integration, staff recommends upgrading to the Fusus Enterprise platform, which will provide enhanced functionality for the City's Real-Time Response Center (RTRC). This upgraded platform will allow TPD to integrate public and community video sources, significantly enhancing incident response and investigations. Since Fusus was acquired by Axon around the time of the original agreement, the licensing level needs to be adjusted to align with the FUSUS Enterprise platform.

To provide historical context, the first-year cost under the second amendment combined the second-year expenses for the body-worn and in-car cameras, TASERs, and the first-year costs for the OSP Premium package. The costs for years 2-5 are higher due to one-time implementation and equipment refresh costs. For years 6-10, the annual cost will be approximately \$970,000. The total cost of the second amendment was \$10,649,140.21.

The City expects sufficient funding in salary savings to cover the first-year costs of this agreement. In addition to the \$1,615,000 in federal funding already secured, TPD is actively pursuing other funding sources to offset General Fund expenses.

Staff recommends approval of the following increases to the Axon agreement: TASER device allocation increase by 70 units (\$233,584.65) and Fusus Enterprise platform upgrade for the Real-Time Response Center.

These adjustments are necessary to ensure TPD's operations continue to be fully supported and to meet the growing technological needs of the department.

The Police Chief recommends that City Council approve the third amendment to the existing agreement with Axon Enterprises, Inc. (C2022-184).
